Enforcement organization, enforcement proceedings, notification, periods, vacation and talik situations, follow-up request and payment order, debtor's objection, removal and cancellation of objection, negative declaratory and restitution cases, property declaration, provisions regarding seizure and seizure, remuneration procedure, sales phase and termination of the tender, distribution of money and certificate of insolvency constitute the content of the course.
