Course Description:	This course is a continuation of Enforcement and Bankruptcy Law I and covers special proceedings and regulations related to bankruptcy law. Proceedings specific to money receivables arising from subscription agreements, proceedings through attachment of bills of exchange, eviction of leased immovables, execution with judgment and conversion of pledge into money are examined. In addition, precautionary attachment, types of bankruptcy (bankruptcy with and without follow-up), opening of bankruptcy and its consequences, liquidation process, removal and closure of bankruptcy are discussed. The conditions, results and current practices of the concordat institution are also evaluated within the scope of the course.
