Course Content:	This course covers the procedure and results of notification procedures within the framework of the purpose, importance and legal nature of notification law. Basic topics such as the arrangement of notification documents, the authorities that will issue notifications, notification through PTT and private/officer, notification to the addressee and his representative, irregular notification and its consequences, notification by announcement, electronic notification, notification with foreign elements are within the scope of the course. In addition, special notification regulations in the Enforcement and Bankruptcy Law and the Tax Procedure Law and the case law of the Court of Cassation are also discussed.
